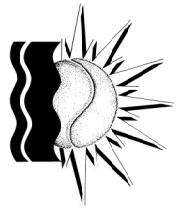

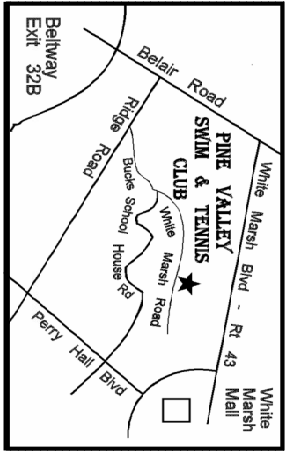


Directions:

The Parent, individually and for the Parent's child[ren], agrees to and does knowingly waive the right to trial by jury in any dispute between the Parent and/or the Parent's child[ren] and any of the Released Parties. The Parent agrees to reimburse the Club for all damages caused by the Parent or the Parent's child[ren] to any Club property.
